#### AFFIDAVIT (OR AFFIRMATION) AND APPLICATION FOR A CERTIFICATE OF RESIDENCE

You must submit a Certificate of Residence, issued by your Home County Treasurer's Office, to FLCC once **EACH YEAR**. **Failure to submit the appropriate document by the payment due date will result in the charge of an Out-of-County tuition premium of \$214.00 per credit hour for the 2023-2024 Academic Year.** 

Please read the instructions below **before** completing the application on the reverse side.

#### **Certificate of Residence**

A Certificate of Residence verifies that you have been a New York State resident for one year prior to registering for the semester. Certificate(s) also state your county(ies) of residence for the past six months. Students registering without a Certificate of Residence will be charged an Out-Of-County tuition premium. Also, per New York State Education Law, you must submit a valid Certificate of Residence to the College once EACH YEAR

- Certificates are valid only when dated **no earlier than** <u>60 days</u> <u>prior to the student's registration date and no later than <u>30 days</u> <u>after the start of classes</u>. Certificates are valid for one year from the date of issue (please check with your County Treasurer's Office for any exceptions). Updated Certificates are required each year. Students who fail to submit their Certificates within the timeline mentioned above will be charged an Out-Of-County tuition premium.</u>
- If you are taking credit-bearing courses (refer to course details), you must obtain a Certificate of Residence (required by New York State law to obtain In-State tuition rates).

#### **Non-Ontario County Residents:**

## NOTE: LIVING IN ONTARIO COUNTY TO ATTEND COLLEGE DOES NOT CONSTITUTE PERMANENT RESIDENCY.

If you have been a permanent resident of New York State for the past year BUT, you have lived outside of Ontario County, please follow these instructions:

- 1. Print neatly all information requested in the **shaded areas**.
- 2. **Submit** it to your County Treasurer. (**Please Note:** Some counties require a photo ID to accompany the application. Please check with your County Treasurer's Office for their requirements.)
- 3. Your County Treasurer will keep this form and give you a Certificate of Residence. Submit that form to the Office of Student Accounts or the One Stop Center. Certificates must be dated within 60 days prior to registration and 30 days after the start of the semester.

### **Ontario County Residents:**

## NOTE: LIVING IN ONTARIO COUNTY TO ATTEND COLLEGE DOES NOT CONSTITUTE PERMANENT RESIDENCY.

If you have been a legal resident of New York State for the past year AND a resident of Ontario County for the last six (6) months, please follow these instructions:

- 1. Your Certificate of Residence Affirmation can be accessed through your To-Do list at MyFLCC.
- 2. Once your affirmation is submitted, the Out-of-County tuition premium will be removed from your bill.

Education Law, Section 6301, paragraph 4, defines: Resident – A person who resides in the state for a period of at least one year and in the county, city, town, intermediate school district or school district, as preceding the date of such person's registration in a community college, or for the purpose of Section Sixty-Three Hundred Five of this chapter, his application for a certificate of residence.

<sup>\*</sup> Education Law, Section 6305 provides "The Chief Fiscal Officer of each county, as defined in Section 2.00 of the Local Finance Law, shall, upon application and submission of him of satisfactory evidence, issue to any person desiring to enroll in a community college as a non-resident student, a certificate of residence showing that said person is a resident of said county...Such person shall, upon registration for each college year, file with the college such a certificate of residence ISSUED NOT EARLIER THAN TWO MONTHS PRIOR THERETO, and such certificate of residence shall be valid for one year from date of issuance."

<sup>\*\*</sup>In the event that a person qualified as above for state residence, but has been a resident of two or more counties in the state during the six months immediately preceding his/her application for a certificate of residence pursuant to Section Sixty-Three Hundred Five of this chapter, the charges to the counties of residence shall be allocated among the several counties proportional to the number of months, or major fraction thereof, of residence in each county.
