*Freshman students may apply for a maximum of \$5,500 annually. Sophomores may apply for a maximum of \$6,500 annually after they have completed 32 credit hours or had an equivalent number of transfer credits. (Independent students may apply for an additional \$4000 annually. These additional funds are always unsubsidized.) Stafford loans may be subsidized or unsubsidized depending on financial eligibility. Students are responsible for the interest on an unsubsidized loan, which may be paid while the student is in school or accrued and then added to the principle balance when the student enters repayment. Interest on subsidized loans is paid by the federal government while the student is in school.

Important Notice: Loans will be disbursed in two equal disbursements during the fall and spring semester. If you are scheduled to graduate at the conclusion of the Fall 2011 semester, your loan will be certified for only Fall. If your first semester at FLCC is Spring 2012, your loan will be certified for only Spring 2012. Single semester loans will be disbursed in two equal disbursements during the semester. The first disbursement will arrive 6 weeks after the start of the term and the second will arrive after the midpoint of the term.
