Federal PLUS Loan Pre-Qualification Form

You may find it necessary to obtain additional funding to contribute toward your child's education. We believe one of the best sources to support your investment is your student's future is the Federal Parent Loan for Undergraduate Students (PLUS). Please use this pre-approval form to initiate the application process.

Choose a Lender:

Please complete and fax the form on the reverse side to ONE lender of your choice. Of special note to previous PLUS borrowers, if your lender is not listed, please write its name next to PLUS amount you are requesting. (For more information about lenders, please go to www.elmselect.com)

The lender will determine your eligibility for the PLUS Loan by performing a credit check to determine your pre-approval status. Both you and the Financial Aid Office will be notified of the decision.

For pre-approved borrowers, your lender will provide you with additional instructions about completing the PLUS Master Promissory Note (MPN). The Lender must receive a completed MPN before your loan processing can be completed. The Financial Aid Office will then electronically transmit the loan certification to your chosen lender. For subsequent borrowers on behalf of this student while enrolled at FLCC, only the Federal PLUS Loan Pre-Qualification form and credit approval will be required.

Approvals:

The PLUS Loan allows you to borrow up to the cost of attendance less any financial aid received. The loan will disburse in two equal payments. Please note that some lenders will subtract a 3% origination fee from the amount of each disbursement.

Denials:

If a parent is denied the PLUS loan, the student may be eligible for additional Federal Unsubsidized Stafford Loan funds. The amount of the loan is limited and will be determined by the Financial Aid Office. Please contact the Financial Aid Office for more information.
