Catalog Description This is a preparatory class for students interested in becoming New York State Department of Environmental Conservation (NYSDEC) licensed pesticide applicators. This course presents information regarding proper procedures for managing pests in the landscape and acts as the 30-hr course required by the NYS DEC prior to testing. Students will be given the opportunity to take the state examination for licensure.
